Terms and Conditions

Terms: The term is the duration of the Event specified in this agreement

Equipment: The equipment, including Accessories (if taken) are specified in the Equipment to be Rented section of this agreement.

SETTLEMENT: All terminals will charge to the card holder a debit Network Access Fee of \$1.00. All Credit transactions will be subject to a Merchant Discount Rate . All Credit/Debit transactions deposited into The Exhibitor Support Centre's Bank Account will be settled at the end of the event (Minimum time line of 5 business days, to a maximum of 10 business days), upon the terminal's return and upon Credit (signed) and Debit receipts presented to The Exhibitor Support Centre,

Inspection & Delivery: You shall examine the equipment supplied under this agreement as soon as it is received and sign off on the condition of the equipment supplied.

Title & Security: Title to the equipment will not be transferred to the “**Exhibitor**”. **The Exhibitor Support Centre** may file under applicable property security laws evidencing its security interest in the equipment and the agreement.

Use & Location: Provided the “**Exhibitor**” continue to satisfy all obligations under the agreement, permits the Exhibitor to have the exclusive use of the equipment. The **Exhibitor** shall keep the equipment safe and out of harms way, including inclement weather and not remove the equipment from the province where the event is taking place.

Insurance: the Exhibitor agree that the “**Exhibitor**” have adequate and proper insurance for this Event, and that The Exhibitor Support Centre can process with making a claim on the equipment for its full replacement cost against loss by physical damage, fire, theft and all other losses customarily covered by such insurance.

Damage & Loss: If the “**Exhibitor**” is not insured, the Exhibitor bear all risk of damage to the Equipment, shall promptly notify The Exhibitor Support Centre of any damage, and shall repair the equipment at the “**Exhibitor**” cost. The Exhibitor Support Centre will inspect the equipment at any reasonable time, with or without notice. If the equipment is partially or fully destroyed, damage beyond repair, stolen or taken from the “**Exhibitor**” legally or otherwise, the ”**Exhibitor**” shall be charged up to the full retail value of the terminal (\$2500.00 Cdn.).

Transactions: Settlement of credit cards transactions shall only be honored with **signed copies of receipts presented to** The Exhibitor Support Centre.

End of Term: The “**Exhibitor**” shall return the equipment to The Exhibitor Support Centre on or before the return date and time specified under the rental terms in this agreement. Upon return of the Equipment to The Exhibitor Support Centre and the equipment is deemed by he Exhibitor Support Centre to be undamaged and fully functional, all accounts will be settled to the “**Exhibitor**” by cheque or Bank transfer for “**Exhibitor** credit and debit transactions.
